RENTAL AGREEMENT

INTRODUCTION

1. Welcome to Intouch 24/7 Rental Registration No. 2018/579750/07, a rental company that is inspired to provide alternate modes of transportation. This rental agreement describes the terms and conditions that govern your use of our services.

ACCEPTANCE

2. BY REGISTERING AN ACCOUNT WITH INTOUCH 24/7 RENTAL (PTY) LTD (ALSO REFERRED TO AS "WE", "US", OR "OUR") YOU ARE INDICATING THAT YOU HAVE READ, UNDERSTOOD AND ACCEPT TO BE BOUND BY THE TERMS AND CONDITIONS OF THIS AGREEMENT. IF YOU DO NOT ACCEPT THIS AGREEMENT, YOU MUST NOT REGISTER AN ACCOUNT.

DEFINITIONS

"the Renter" means the person who have registered an account with us in order to make use of our vehicles to move around the city both for business and leisure.

"Business" means going to any place using our vehicles for work purposes and without using it to transport passengers for reward.

"Leisure" means time spent away from work, business

"Rental period" means the time between the start of the trip and end of the trip.

CHANGES AND UPDATES OF THE TERMS AND CONDITIONS

- 3. The Terms and Conditions of this Rental Agreement may be updated from time to time and the Renter is required to visit the website frequently to read up on the latest revision. We will post a notice of any changes and updates prior to implementing them.
- 4. The Renter is also required to keep us informed about any changes in her/his information that is submitted to us. Failure to do so constitute a contravention with this Rental Agreement.

BECOMING A MEMBER

- 5. To have access to our vehicles, the prospective Renter is required to register by filling out the registration form and provide all the necessary information requested. For security reasons, we conduct rigorous background checks before any registration can be accepted to ensure the vehicle is given to the correct person. A third party may be used as stated in the Privacy Policy to assist us with such verification checks. Although we do our best to attend to the membership requests as quickly as possible, please know that each process can take up to 5 days maximum to conclude. Your acceptance request will be communicated via an email.
- 6. Intouch 24/7 Rental reserves the right to request any other relevant information at any time.
- 7. The Renter shall lawfully, accurately, truthfully and fully complete the registration form and provide all the necessary information requested. The Onus rest with the Renter to keep his/her information on our database updated at all times. Failure to do so constitute a contravention with this Rental Agreement.
- 8. We reserve the right to refuse new registration as well as to immediately terminate existing membership for the following reasons, but not limited to:

- You fail to disclose crucial information for registration such as accident history, etc
- You fail to conform to this rental agreement
- You fail to keep your details in our database up to date
- Misuse of our vehicles
- Towing of another vehicle without our consent
- Tempering with our vehicles including removing any part of a vehicle without our consent

ADDRESSES FOR COMMUNICATION PURPOSES

- 9. Any communication between us and the Renter will be deemed to have been duly received when such communication is sent to the addresses provided to us by the Renter.
- 10. For any legal matters, the Renter agrees that the addresses provided are his/her Domicilium citandi et executandi.

ELIGIBILITY

- 11. We use the information provided at registration stage to determine your eligibility to use our vehicles. The Renter will have to pass our verification checks in order to be able to make a booking.
- 12. Vehicles will be rented out to permissible drivers that are aged between 25 and 70 unless agreed otherwise.

DRIVERS LICENCE

- 13. The Renter will be required to produce her/his valid driver's licence upon picking up the vehicle. Expired driving licences will not be accepted.
- 14. Only authorised Renters that can drive our vehicles.

ADDITIONAL DRIVER

15. An additional driver may be added at a cost of R350.

CONDITION OF OUR VEHICLES

- 16. Our vehicles are not brand new but are fairly in a good roadworthy condition and are tested yearly by DEKRA.
- 17. In the event of an accident or breakdown, the Renter will be chauffeured to her/his destination while the vehicle is being repaired. If the vehicle cannot be fixed within 24 hours and there's no replacement, the Renter will be refunded for the remainder of the rental period.

USE OF OUR CARS

- 18. Our cars are made available for private use; not for business use such as transporting passengers for reward.
- 19. The Renter is required to comply with all South African laws and regulations as stipulated in the road traffic act.
- 20. Our vehicles are permitted to drive within a radius of 100km from our office unless arranged otherwise.

VEHICLE TRACKING AND GLOBAL POSITIONING SYSTEM (GPS)

21. Our vehicles are equipped with vehicle tracking system and Global Positioning System (GPS) to assist with the recovery in the event of a theft as well as to monitor its status regarding any accidents.

BOOKINGS

- 1. Our vehicles can be booked by contacting us and they are available on a minimum period of 3 days and a maximum of 1 month.
- 2. Prices are calculated based on the pick-up and drop-off times and dates as agreed between the Render and us.

CHANGES TO THE BOOKING/ CANCELLATION

- 3. Changes to the booking and/or cancellation can be made by contacting us at least 48 hours before the start of the trip, the Renter will be refunded in full.
- 4. No refund will be made for any cancellation made in the 48 hours period before the start of the trip.

PAYMENT FOR THE BOOKING

5. Once a booking is accepted, the Renter will be required to make the payment for the booked trips within 24 hours after the booking has been made. No bookings will be reserved if no payment is made by the required time.

ADDITIONAL AMOUNT, CHARGES, FEES

- 6. The Renter is responsible for all other costs such as parking, toll road fees, fuel, traffic fines, etc that will be incurred during the rental period as well as any damages suffered by Intouch 24/7 Rental. These costs will be calculated and deducted from the deposit at the end of the trip.
- 7. In the event that there is no deposit paid, the Renter will be required to settle the costs at the end of the trip or within seven (7) calendar days.
- 8. If no payment made after the seven (7) calendar days, the account will be placed with a debt collection agency.
- 9. The following is the schedule of payment:

PICK UP AND DROP OFF

- 10. The Renter shall arrange for a pick up or drop off that suites her/his convenience by contacting us in advance. Pick-ups and drop-offs within a radius of 25km from our office are charged at R100 each way. Alternatively, the Renter is free to pick up and/or drop off the vehicle at our office.
- 11. Upon delivery/ dropping off of the vehicle, an inspection will be conducted by completing the checklist by both parties. This has to be supported by photos taken before and after the trip.

EXTENSIONS

12. Extension requests can be requested and approved if the vehicle being used is still available 48 hours before the trip ends.

LATE RETURNS

13. Any late returns exceeding 1 hour will be charged at 2 times the daily rate.

SECURITY DEPOSIT

- 14. The Renter will be required to pay the refundable deposit of R 3500 when making a booking. This upfront deposit requirement may be relaxed for regular Renters if prior arrangement is made.
- 15. You also provide us with permission to deduct from your deposit for any fines, charges, damages, etc that are due to us. If there are no deductions required and all conditions have been met, the full amount will be returned after seven (7) days from the last trip.

PARKING

16. It is the responsibility of the Renter to park the vehicle at a secured place at night including ensuring that the doors are properly locked. The car keys are to be kept by the Renter at all times.

CLEANING AND MAINTENANCE

17. The Renter is responsible to leave the vehicle in a clean, tidy and ready for the next user or as they have found it. A minimum of R100 will be charged if the vehicle is left dirty and untidy at the end of the trip.

NO SMOKING

18. Smoking is not permitted inside the vehicles. A fine of R350 will be charged if this policy is not adhered to.

NO PETS

19. Pets are not permitted inside the vehicles. A minimum of R350 fine will be charged if this policy is not adhered to.

INSURANCE AND DAMAGE

- 20. The rate include a full comprehensive insurance cover to protect the Renter in the event of accidents.
- 21. All collisions, accidents, defects, or damage and theft of the vehicle to be reported to the South African Police Service (SAPS) immediately. The Renter further need to notify us within 3 hours.

- 22. The cover is only valid if the Renter sticks to the terms of this Rental Agreement.
- 23. If the investigation by SAPS or any other suitable person indicate that the damage was caused by reckless or negligent driving, inconsiderate driving, driving while under the influence of intoxicating liquor or a drug having a narcotic effect, and miscellaneous offences driving in the gravel roads, the full amount of the damage to **Intouch 24/7 Rental** and third party (other car/property etc.) will be the Renter's responsibility.
- 24. Minor scratches on the body of the vehicle, tyres, windows, interior, undercarriage or minor damages that are not covered by the insurance.

DAMAGE EXCESS

25. The Renter will be fully responsible for paying excess of **R10,000** required by the insurance in the event of accidents and incidents.

FUEL AND REFUELING

26. The Renter is to replace the fuel to the same level as agreed on the trip inspection checklist.

EXCESS MILEAGE

27. The rate include free 150km for each day. Excess mileage will be charged at R2,50 per kilometre

DEDT COLLECTION

28. The Renter authorises Intouch 24/7 Rental to place unsettled accounts with a debt collection agency. Any costs whatsoever that arise during this process including payment of the agency itself will be the responsibility of the Renter.

DISCLAIMER

29. Our vehicles are used at Renters own risk. **Intouch 24/7 Rental** shall not be liable for any indirect and/or consequential damages or any other damage regardless of whether the liability to which such damages arises in contract, tort, or otherwise in law, for any injury, loss, or damage sustained by the Renter arising from this Agreement or the use of our vehicles.

COMPLAINTS

- 30. The Renter can contact us for any complaints.
- 31. Complaints related to the booking can be made within 2 months of the last trip.
